### Kids Hope Alliance – March Finance Meeting Minutes March 25, 2024

1. Introductions and Instructions Cynthia Nixon, Finance Chair

Cynthia Nixon called the meeting to order at 2:00 p.m.

- 3. Approval of Minutes Mrs. Nixon asked the Finance Committee if there were corrections to the minutes from the January meeting and there were none.

- The criteria for the youth participating in the organizations which receive funding from the Youth Travel Trust Fund.

- A breakdown of contracts which make up the \$650,000 in the Professional Services category.

a. STEM Hub: 100 Black Men & I'm a Star Foundation Kenneth Darity, Chief Administrative Officer

Mr. Darity asked the Board to approve funding for 100 Black Men of Jacksonville, Inc. and the I'm A Star Foundation, Inc. to implement a STEM HUB program for underrepresented youth in the amount of \$200,000 each for a total of \$400,000.00.

The contract period is August 1, 2024 through May 31, 2025 with the option to renew for two additional one-year terms. Both of the providers have been operating this program for the last 3 years. After some discussion, Mrs. Nixon asked for public comments, there were none.

b. Grant Application: TD Charitable Foundation Rodger Belcher, Chief Strategy Officer

Mr. Belcher asked the Board to approve the application to fund the Home Roof Rehabilitation Initiative. This is a pass through grant in partnership with the City of Jacksonville's Neighborhoods Division. If awarded, it would provide home roof repair for 15 families identified to have at risk children. The grant award is \$250,000 and there is no cash match required. After some discussion, Mrs. Nixon asked for public comments, there were none.

c. Grant Application: DCF Criminal Justice Reinvestment Grant Rodger Belcher, Chief Strategy Officer

Mr. Belcher asked the Board to approve the application to fund the Criminal Justice Reinvestment Grant. If awarded, this would be the 4<sup>th</sup> grant in a series of 3 year grants that KHA has received in collaboration with the Partnership for Child Health and the Jax. Sheriff's Office.

This grant submission will serve youth who are identified as "at-risk" for involvement in the juvenile justice system. \$1,200,000.00 funding is available over a three year period. Local matching funds of 100% are required under the Reinvestment Grant Program and will be provided by the Jacksonville Sherrif's Office for detention, security and space.

KHA provides a cash match up to \$85,000 for grant management support and monitoring. Mrs. Nixon asked if we would provide the total amount of funding KHA and JSO would

expend over the three year period, Dr. Grass indicated that we would provide that figure in future meetings. After some discussion, Mrs. Nixon asked for public comments, there were none.

 Grant Application: Treasury Department's Social Impact Partnerships to pay for Results Act (SIPPRA)
 Dr. Saralyn Grass, Chief Executive Officer

Dr. Grass asked the Committee to approve the application for this grant from the U.S. Department of Treasury's Office of Economic Policy.

The Institute for Child Success works with investment funders who participate in social entrepreneurship. This grant will pay for the Institute to perform a landscape analysis of Jacksonville's current literacy initiatives. This "Pay for Performance" model would focus on improving student's third grade reading scores and school readiness. The Mayor's office is very interested in this participating in this grant.

Grant awards are expected to pay back \$10,000,000 in investment funding if available with a 50 percent match, but the match required does not need to be from the applicant. If the required federal savings outcomes are met at the end of program, the Treasury will provide the full requested amount. If the required federal savings outcomes are not met at the end of the program, no penalties will be issued.

e. Literacy Training and Coaching Contract Dr. Saralyn Grass, Chief Executive Officer

Dr. Grass explained that this funding (\$750,000) is part of the monies which came from the Mayor's budget of \$6,000,000 and has been set aside for literacy programs, coaching, and training. KHA has been working with DCPS and the ELC to build upon their current training which is being delivered by the University of Florida.

This summer, there will be a one week training institute with UF and beyond that UNF will hire local coaches who will be trained by UF to maintain consistency. This training will cover Teacher training for the K-2 grade levels.

KHA will work with the ELC to address literacy training for the birth to 5 age group. The contract date is June 1, 2024 to May 31, 2025 for year 1 and for subsequent years with up to three (3) annual renewal options. Each subsequent year's option will be based on an evaluation of the effectiveness of the prior year.

f. Recapture Funds Legislation Dr. Saralyn Grass, Chief Executive Officer Shari Shuman, Compliance

Shari Shuman explained that KHA receives funding from the City's General Fund. Those monies are transferred to KHA on a quarterly basis. At the end of the year, if KHA has not expended the funds, the city moves the unused funds from KHA back to the General Fund.

KHA would like permission ask City Council to return these leftover monies back. This year's amount is \$1,400,000 which is being recaptured from year end processing for FY 2022-2023: \$1,076,498 will go towards funding providers that responded and scored well on our last RFP but were not funded due to limited funding. \$140,000 will go towards opening a new OST site in or near the Eureka Gardens area (Valencia Way). The remaining amount will go to Early Learning to expand ongoing literacy efforts.

Upon approval by KHA's Board and the full City Council, the fiscal impact will be a total of \$1,433,508, with \$1,216,498 funding new programming and the remainder to expand existing literacy efforts. This money will be carried forward to the KHA 2024/2025 budget. After some discussion, Mrs. Nixon asked for public comments, there were none.

Jessica Pitts reviewed the preliminary budget for FY 24-25 which included an overview of the Original and Current Budget for FY 23-24, current year's actuals, the monies KHA is projected to spend and the proposed requested budget for FY 24-25 and any changes.

She also indicated that Senior Leadership may come before the Committee to ask them to fund additional staff given the increased number of contracts which are being executed.

## **REQUESTED ACTION:**

The Board is asked to:

- 1) Approve the application for the grant opportunity from the State of Florida's Economic Development Initiative (EDI) Youth Crisis Center Youth Multi-Purpose Center.
- 2) Authorize the CEO of Kids Hope Alliance to execute a grant contract with the funder, and all other documents necessary to comply with grant requirements, if awarded, including direct contracts with the partner identified in the grant.

## **NARRATIVE:**

The Kids Hope Alliance, in partnership with the Youth Crisis Center (YCC), seeks funding from the Community Development Fund statute 5305(a)(4) which is intended for: clearance, demolition, removal, reconstruction, and rehabilitation of buildings and improvements. These improvements should promote energy efficiency and include interim assistance, financing for public or private acquisitions and the renovation of closed school buildings. This grant must be in partnership with a government entity.

The Youth Crisis Center has a multi-purpose recreational center which will be used for youth ages 10-17 who are homeless, trafficking victims, runaways, experiencing mental health concerns and/or need immediate housing and crisis services. These youth will temporarily reside in a residential runaway/homeless youth shelter and receive all services in one building. Services include academic instruction, therapy, life skills, groups, meals, nursing services and housing. Program youth require large muscle movement and a safe space to do so. The Youth Crisis Center does not currently have adequate space for a variety of activities. This center would provide an alternative to the indoor space where youth currently live.

The purpose of the Economic Development Initiative grant is:

(1) To improve the lives of individuals, in need, by providing recreational services while youth are in the Youth Crisis Center

The grant award begins October 1, 2024 through December 31, 2024.

## FISCAL IMPACT:

Grant awards are expected to be up to \$534,000 which will be a pass-through to the Youth Crisis Center.

## **REQUESTED ACTION:**

The Board is asked to:

- 1) Approve the application for the grant opportunity from the Office of Justice Programs (OJP) Community Based Violence Intervention and Prevention Initiative Site Based.
- 2) Authorize the CEO of Kids Hope Alliance to execute a grant contract with the funder, and all other documents necessary to comply with grant requirements, if awarded, including direct contracts with the partner identified within the grant.

## NARRATIVE:

OJP seeks to prevent and reduce violent crime in communities by supporting comprehensive, evidencebased community-based violence intervention and prevention programs. These programs include efforts to address gang and gun violence, based on partnerships among community residents, local government agencies, victim service providers, community-based organizations, law enforcement, hospitals, researchers, and other community stakeholders.

Community Violence Intervention (CVI) is an approach that uses evidence-informed strategies to reduce violence through tailored, community-centered initiatives. These multidisciplinary strategies engage individuals and groups to prevent and disrupt cycles of violence and retaliation and establish relationships between individuals and community assets to deliver services that save lives, address trauma, provide opportunity, and improve the physical, social, and economic conditions that drive violence.

Kids Hope Alliance in partnership with The Partnership for Child Health submits a grant application which will help ensure the Duval jurisdiction has access to expertise to address community violence that involves youth, young adults, and adults, both as the individuals responsible for perpetrating this violence and as those who are victims of it.

Utilizing a restorative justice framework, Jacksonville's Safe and Flourishing Environment-System of Care (JaxSAFE-SOC) will work to build the capacity of families and communities by developing and implementing trauma-informed and culturally responsive prevention and early intervention strategies that will increase both the resiliency of children and youth exposed to violence and enhance the protective factors in their community to mitigate and prevent violence. Advancing both the healing of individuals and community trauma resulting from exposure to violence will in turn, promote collective resilience through cohesiveness and connection.

**JaxSAFE-SOC** will focus on youth under the age of 21 who are affiliated with, involved in or at-risk of gang or gun involvement or violence interactions as identified by the Jacksonville Sheriff's Office Gang Investigation Unit or by Cure Violence, a Global Violence Intervention model deployed in Jacksonville to identify high risk individuals by disrupting violence through mediation.

**JaxSAFE-SOC** will serve high-risk youth in Jacksonville's Health Zone 1 (HZ1), an area that has been plagued with a string of gang and gun violence stemming from multiple murders of youth. While Duval County's population is 31% Black, HZ1 has the largest percentage of minority residents (81%), highest poverty rates (30%), the lowest percentage of population with a high school education (35.7%), and the highest death rates.

Leveraging the Mayor's Crime Prevention Initiative, the Jacksonville Journey, **JaxSAFE-SOC** will integrate, restructure and expand the foundational components of the violence intervention System of Care to address the high prevalence of gang and gun violence among young people.

The grant award begins October 1, 2024 through September 30, 2027 or 36 months.

## FISCAL IMPACT:

Grant awards are expected to be up to \$750,000 in funding for 36 months that would be a pass-through to the Partnership for Child Health.

The JSOCC program integrates System of Care principles and offers communities access to health professionals with the capacity to provide medical, mental, behavioral, and transition health services to children and youth at-risk for or experiencing serious emotional disturbances and serious mental illness. JSOCC is a scalable and replicable model of a Medical-Behavioral Health Homes network of pediatricians qualified to diagnose and manage low to mid-level mental health conditions of high-risk populations of children and youth.

- 2,451 Youth have received behavioral health care coordination and referred into therapeutic and/or psychiatric services.
- 448 Youth successfully completed High-Fidelity Wraparound
- **510** Individuals trained in mental health related trainings (MHFA, IEPs, etc)

# ReCAST

### Building a Resilience Jacksonville - SOC

*BRJ-SOC* utilizes a rights-based framework to create an ecosystem of care to solidify, sustain and build upon community-based participatory efforts; meet the needs of high-risk youth and their families; and promote well-being, resiliency, and community healing. The initiative serves more than 15,000 individuals in Jacksonville's urban core, home to the city's largest percentage of minority residents, highest poverty rates and highest death rates. The initiative is funded by a SAMHSA *2021 Resiliency in Communities After Stress and Trauma (ReCAST)* grant.

- Served more than 6000 youth and families in Health Zone 1 through the provision of resilience activities, trauma informed summer camps, and faith-based trauma interventions;
- Trained 547 mental health workforce and related workforce members in behavioral or mental health trauma informed approaches;
- Provided 1,129 youth with trauma-informed behavioral health services through collaborations with Hope and Healing Jax, Noah's Ark, Kash Kids, Northwest Behavioral Health, and Step-by-Step 4 Help.

# **CREATE-SOC**

### Co-Designing Rich Environments for all to Thrive Everyday

The *CREATE* System of Care (SOC) will expand on the foundational SOC components of being family-driven, youth-guided and cultural competency to address three priority populations of children identified by SAMHSA--children and youth with special health care needs (CYSHCN), those transitioning from pediatric to adult care (HCT), and LGBTQ+ children and youth (C&Y). They represent a third of US children, are at high risk for SEDs, and are disproportionately represented by minority and low-income families. CREATE will implement two behavioral health teams consisting of a LCSW, Wraparound prepared Care Coordinator, and Family Advocate who will work with the populations of focus. A Collaborative Care model will be used to train pediatricians on psychiatric med management and mental-behavioral health approaches to their patients.

# INSPIRE

Identifying Needs and Supports to Partner, Intervene, Reengage and Educate

This multi-agency comprehensive anti-gang program for youth is a collaboration that mobilizes faith and community organizations and partners with the government and private sectors. Project *INSPIRE* integrates key components of the Office of Juvenile Justice and Delinquency Prevention (OJJDP) *Comprehensive Gang Model, Project Safe Neighborhoods and the Gang Reduction* program to reduce and sustain reductions in community youth violence and gang victimization.

- 91% of youth on track to graduate (grades 9-12) at time of enrollment in INSPIRE has graduated with high School employment or is still enrolled in school.
- Over the duration of the program 94% of enroll youth without a criminal record has not been arrested. (Including gun related charges or negative encounter with law enforcement).
- 86% of youth 16 years and older obtained gainful employment with 8 months of enrollment.

# CJRG

### Criminal Justice Reinvestment Grant

The primary goal of this Grant Agreement is to screen and assess all youth entering the juvenile justice system to identify early social and emotional health issues. CJRG fills the intervention gap at the front end of the juvenile justice system by connecting youth and their families with behavioral, social, emotional, and educational needs with early intervention services to prevent recidivism and provide additional opportunities for the youth to be diverted from the criminal justice system.

- **89%** of youth did not re-offending while enrolled in programming
- 81% of youth successfully completed the program
- 93% of youth did not re-offend within 6 months of discharge

- 83% of youth enrolled remained violence free
- **86%** of program youth have not reoffended
- 93% of youth not enrolled in school have reenrolled in an educational program


