Dr. Grass mentioned that on November 6th a survey will be sent to Board members to determine their availability for upcoming meetings. This information will be used by Committee Chairs to create a slate of meeting dates which will be discussed at the next Board meeting.

Dr. Grass then announced that due to her promotion to CEO, a Chief Strategy Officer position had been advertised and Rodger Belcher will be promoted to this position. She also announced that Kenneth Darity is being promoted to Chief Administrative Officer and to round out the Senior team, Jessica Pitts will be joining them as the Director of Finance. These promotions take effect on November 6th.

Dr. Grass provided an update on the \$5.8 million dollars which is being allocated to KHA from the Mayor's budget. These funds are moving forward to City Council for approval. After City Council approves these additional dollars, the Board will have the opportunity to vote on how the funding will be utilized. Other KHA initiatives include participation in the Mayor's Literacy event on January 20, 2024 and re-establishing a Book Mobile. A rendering of the Book Mobile will be shared at the Mayor's Literacy initiative in January.

Mr. Darity provided programming updates which include the distribution of 2200 Fair tickets to youth in KHA-funded programs, acknowledgement of the collaborative work being performed by staff and a successful Nutrition focus group.
